Don Allan has received a building fund grant application and a DeSmit new dancer class grant application. These will be shared and reviewed after the January 15 application deadline.

REPORTS –

Treasurer's Report – Don Allan

- There has been activity with the Valley Circle having published 3 issues and received renewal revenue.
- The Gala made a profit of approximately \$200.

- Registrations were sent to the BCSRDF on the November 15 due date, with Abbotsford Grand Squares not yet submitting their registrations.
- Don normally uses the Directory to submit information on club Executives; Blair said he has all data except for Guys 'n' Gals (which as a caller run club is Tyler), and he will provide it to Don.
- It is important to meet deadlines as there is a cascading effect. For example, not having insurance in place could affect the ability to book halls.

B. Valley Circle/Website – Blair Wallace

C. Promotion Committee – John Corrigan/Greg Dahlgren

John

This is my first report as the new chairperson of the joint promotion committee. We have reviewed the use of the coffee news as a vehicle to promote square dancing. We will have to use it again in November, December and January for the start of spring classes. We will also continue to use Facebook to promote individual new dancer classes as well. We will be working with the VDCTA to setup a series of dances with the new callers and cuers in areas that don't currently have square dance clubs. We are looking forward to the next year being successful in recruiting new dancers.

I will start FB ads again in December for any clubs running new dancer classes in Jan.

Pre-Christmas, these ads will be generic Square Dancing ads promoting our hobby in general. The link to DanceForFun.ca will be included so people have a contact point for most enquiries.

Greg expressed some doubt as to the value of Coffee News ads, reiterating the stats he presented last meeting. Lyle said not everyone uses Facebook and we should not rely put all our eggs in one basket. Wendy said that Awareness is the first step in a publicity campaign, and a two-pronged approach is good.

D. BC Federation – Dianne Wilson

- Minutes of October 19, 2025 meeting were distributed.

- Dianne said that Pat Zeeman and Garry Dodds came to Town 'n' Country Anniversary dance and were coming to the SSW Anniversary dance today. She further mentioned that the BC Festival 2027 will be a Round Dance Festival in Nanoose Bay, a little north of Nanaimo and that Pat Zeeman and Connie Ritchie were organizing it.
- There are 5 clubs in Northern BC who no longer have an Association, and question whether having an Association would bring any benefit to clubs who are so far apart. Wendy would like to confer with Maureen to provide a response.
- There are still unresolved billing issues with the BC Festival 2025 venue, who between the school district and the school have billed less than the quoted price. It was suggested Bonnie Hartup may be able to help. *Learned subsequently: The venue wants \$441 more, instead of \$1882.95. We are coming out ahead.*

F. Gala Committee – Dave Hammer

The BCSRDF will be putting on a Caller school just ahead of the Festival. The capacity will be 24 students and we have 14 expressions of interest at this point. We have 2 Canadian Callerlab accredited coaches and 2 Canadian caller assistants lined up.

It has funded Promotion Committee projects. The deadline to apply is January 15 and application forms are on the website. Wesburn should apply for a Building Fund grant. Wendy mentioned that Wheeling 8s also have dancers who can't pay. The applications will be reviewed by the Executive at their January 24 meeting,
